EVENT # 14873. BWC INCIDENT. VIDEO WAS VIEWED. IN SUMMARY: JUSTIN TAYLOR (OFFENDER) WAS IN THE FRONT PASSENGER SEAT OF A STOLEN VEHICLE OPERATED BY CO-ARRESTEE ENRIQUE CARLO. JUSTIN TAYLOR(OFFENDER) JUMPED OUT OF THE FRONT PASSENGER SEAT WITH R/O LARA #13954 PERFORMING AN EMERGENCY TAKEDOWN. JUSTIN TAYLOR(OFFENDER) BEGAN FLAILING HIS ARMS PULLING AWAY IN AN ATTEMPT TO DEFEAT A LAWFUL ARREST. R/O LARA #13954 WAS ON TOP OF JUSTIN TAYLOR(OFFENDER) HOWEVER UNABLE TO PLACE HIM IN HANDCUFFS DUE TO RESISTANCE. SGT. EMERGENCY TAKE DOWN AND HANDCUFFING ON A GRAVEL GROUND LEFT JUSTIN TAYLOR(OFFENDER) WITH A BRUISED CHEEK, SCRATCHES ON HIS CHIN, AND AN ABRASION TO HIS LEG. ALL OFFENDERS WERE TRANSPORTED TO THE 014TH DISTRICT FOR PROCESSING. CFD AMBULANCE #62 WAS ON SCENE AT THE 014TH DISTRICT TO EXAMINE JUSTIN TAYLOR(OFFENDER). YOUNG GIRL NOW KNOWN AS OFFENDER DURING THIS INCIDENT. DESTINEY STEWART WITH NO VISIBLE INJURIES WAS TRANSPORTED TO THE 014TH DISTRICT BY BT. 1461D.
