UPON ARRIVAL R/O'S ALONG WITH BEAT 2513(P.O. ZURITA#15091) WERE MET BY [PARENT/BIOLOGICAL FATHER] [REDACTED], WHO STATED THAT HE WAS WORRIED ABOUT HIS DAUGHTER [V] [REDACTED] WHO HASN'T BEEN RETURNING HIS CALLS OR CAME TO PICK UP HER DAUGHTER FROM HIS HOUSE. [REDACTED] STATED HE LAST SPOKE TO HIS DAUGHTER/VICTIM TUESDAY EVENING DECEMBER 7, 2021 @ 1730HRS AND SHE STATED TO HIM SHE WAS DEPRESS ABOUT HER RELATIONSHIP WITH HER YOUNGEST DAUGHTER'S FATHER. WHILE APPROACHING APARTMENT BUILDING [REDACTED] POINTED OUT HIS DAUGHTER/VICTIM VEHICLE(2021 SILVER MAZDA CX-5 IL-PLATE# [REDACTED] PARKED DIRECTLY OUT FRONT. R/O'S OBSERVED NO ONE OCCUPYING VEHICLE AND PROCEEDED INSIDE AND KNOCKED MULTIPLE TIMES ON FRONT DOOR WITHOUT A RESPONSE. BEAT 2513 KNOCKED ON ADJACENT APARTMENT(1-S) DOOR TO POSSIBLY GET INFORMATION REGARDING [REDACTED] (VICTIM) WHEREABOUTS BUT DIDN'T GET AN RESPONSE AS WELL. R/O'S LOCATED A DOCUMENT POSTED ON WALL WITH LETTERHEAD IDENTIFYING THE BUILDING MANAGEMENT AND CALLED THEM FOR ASSISTANCE. BUILDING MANAGEMENT DISPATCHED A MAINTENANCE WORKER OVER WHO TRIED TO OPEN FRONT DOOR BUT WAS MISSING A KEY TO DEADBOLT WHICH HE STATED WERE RECENTLY CHANGED. MAINTENANCE WORKER RELOCATED TO REAR OF BUILDING TO APARTMENT BACK DOOR. MAINTENANCE WORKER WAS ABLE TO OPEN DOOR AND R/O'S ALONG WITH BEAT 2513 MADE ENTRY. UPON BREACH OF DOOR R/O'S STATED OFFICE IN WHICH IMMEDIATELY FOLLOWING BEAT 2513 DISCOVERED ABOVE VICTIM LAYING ON BACK NEAR FRONT DOOR UNRESPONSIVE. R/O'S OBSERVED VICTIM LAYING LIFELESS ON FLOOR WITHIN A POOL OF BLOOD ON LEFT SIDE OF VICTIM FACE. R/O'S CHECKED PULSE AND RECEIVED NO FEEDBACK AND REQUESTED CFD ASSISTANCE VIA RADIO THROUGH OEMC. ENGINE #25 ARRIVED ON SCENE AT 1012HRS AND PRONOUNCED VICTIM DECEASE AT 1024HRS THROUGH DR [REDACTED] OF ILLINOIS MASONIC HOSPITAL. ENGINE #25 STATED TO R/O'S THAT A ENTRY WOUND OF SOME KIND WAS FOUND ON LEFT SIDE OF VICTIM CHIN. R/O'S AND BEAT 2513 SEARCHED IMMEDIATE AREA OF VICTIM FOR POSSIBLE FIREARM/WEAPON. SEARCH RESULTED ONLY IN FINDING ONE GREY COLOR UNKNOWN SPENT CASING (LATER TO BE CONFIRMED AS 9MM AND RECOVERED AND INVENTORIED BY E.T. ON SCENE). BEAT 2513 REMAINED INSIDE APARTMENT TO SECURE CRIME SCENE AND R/O'S RELOCATED BACK TO FRONT OF APARTMENT BUILDING TO SYMPATHETICALLY INFORM [REDACTED] FATHER OF VICTIM CURRENT STATUS. WHILE APPROACHING FRONT R/O'S NOTICED A VEHICLE(2019 GREY COLOR AUDI A-4 IL-PLATE#[REDACTED] DRIVE UP WITH TWO OCCUPANTS LATER TO BE IDENTIFIED AS [OTHER] TYLER, PIERRE BOYFRIEND(FATHER OF VICTIM YOUNGEST CHILD) AND [PARENT/BIOLOGICAL MOTHER] [REDACTED]. MR PIERRE TYLER(STAR#11028, EMP#[REDACTED] UNIT 015) IDENTIFIED HIMSELF TO R/O'S AS AN OFF-DUTY OFFICER WITH CPD AND BOYFRIEND TO VICTIM ALONG WITH HIM BEING THE YOUNGEST CHILD FATHER OF THE TWO CHILDREN THAT THE VICTIM HAVE ([REDACTED] F-1-6, DOB-[REDACTED]/2015), ([REDACTED] F-1-9MNTHS DOB-[REDACTED]/2021). BOTH CHILDREN WERE RESIDING WITH RELATIVES DURING TIME OF INCIDENT. MR TYLER STATED TO R/O'S THAT HE LAST SPOKE TO VICTIM WEDNESDAY AFTERNOON AT 1630HRS ON DECEMBER 8,2021. WHEN ASKED BY R/O'S WERE THERE ANY FIREARMS LOCATED INSIDE OF RESIDENCE, MR TYLER STATED THAT HE LEFT ONE OF HIS HANDGUNS(9MM SPRINGFIELD XDM UNKNOWN SERIAL) INSIDE THE VICTIM BEDROOM IN THE CLOSET ON THE TOP SHELF. MOTHER OF VICTIM [REDACTED] STATED SHE CALLED MR TYLER UPON GETTING OFF WORK THIS MORNING AND STATED THAT SHE WAS WORRIED ABOUT HER DAUGHTER/VICTIM DUE TO THE FACT SHE HASN'T TALKED TO HER SINCE EARLY THIS WEEK AND THE CHILDREN WEREN'T WITH HER. [REDACTED] (VICTIM-MOTHER) RELATED THAT MR TYLER (VICTIM-BOYFRIEND) VOLUNTEER TO PICK HER UP AND BRING HER TO THE LOCATION. R/O'S NOTIFIED AREA 5 DETECTIVE PEREZ#2070 BEAT 5520B @ 1040HRS. AREA 5 DETECTIVES AS FOLLOW WERE ON SCENE AT 1048HRS; DETECTIVE LYNN#21384 BEAT 5514H, DETECTIVE BEBEE#20600 BEAT 5514H, DETECTIVE DALY#20640 BEAT 5514H AND COMMANDER WINSTROM#20 OF AREA 5 DETECTIVES WAS ON SCENE @1330HRS. 025 DESK SGT/WATCH COMMANDER WAS NOTIFIED @ 1105HRS.
