#### FINAL SUMMARY REPORT<sup>1</sup>

#### I. EXECUTIVE SUMMARY

On June 8, 2023, the Civilian Office of Police Accountability (COPA) received a telephone complaint from Ashley Vargas reporting alleged misconduct by members of the Chicago Police Department (CPD). Vargas alleged that on May 13, 2023, Sgt. Mary Martin used language intended to taunt or denigrate individuals.<sup>2</sup> Additionally, Vargas alleged that on May 24, 2023, Sgt. Michael Edens and Commander Elizabeth Collazo both failed to submit a complaint to the Civilian Office of Police Accountability. Following its investigation, COPA reached a sustained finding regarding the allegation that Sgt. Mary Martin used language intended to taunt or denigrate individuals.

#### II. SUMMARY OF EVIDENCE<sup>3</sup>

In her statement, Ashley Vargas, a Community Commission for Public Safety and Accountability (CCPSA) member for the 14<sup>th</sup> District, said that on May 13, 2023, she was at the 14<sup>th</sup> District station, where migrants were being temporarily housed.<sup>4</sup> She stated that she spoke with Sgt. Mary Martin, who was unfriendly and unprofessional.<sup>5</sup> Vargas said that Martin indicated that the migrants should have "done this [immigrate to the United States] the legal way."<sup>6</sup> Vargas also said that Martin would not let the migrants sleep in the lobby because she said that they have diseases and illnesses.<sup>7</sup> After this conversation, Vargas said that Martin kicked her out of the station.<sup>8</sup>

According to Vargas, Vargas and her CCPSA co-councilor, David Orlikoff, met with Commander Elizabeth Collazo and Sgt. Michael Edens for a district council meeting on May 24, 2023.<sup>9</sup> Vargas said during that meeting she told them about Sgt. Martin's behavior and asked how they would deal with the situation.<sup>10</sup> Collazo allegedly told Vargas she would speak with Martin.<sup>11</sup> Vargas asked whether Collazo would make a COPA complaint and Vargas alleged Collazo said she would not.<sup>12</sup> Vargas said that Sgt. Edens also said in this meeting that he could not make a complaint but suggested that Vargas make a COPA complaint.<sup>13</sup> Vargas said that an assistant was taking down notes during this meeting.<sup>14</sup>

In his statement, David Orlikoff, stated that he and Vargas had a meeting with Collazo and Edens on May 24, 2023.<sup>15</sup> Orlikoff said that Collazo told Vargas that Collazo did not want to file a COPA complaint and suggested that Vargas file the complaint herself.<sup>16</sup> Orlikoff indicated that Edens was not asked to file a complaint and that Vargas was more focused on Collazo.<sup>17</sup> However, he also said that Vargas may have directed the request for the complaint to both Collazo and Edens.<sup>18</sup>

In her statement, **Sector** a female migrant who was staying at the 14<sup>th</sup> district station described an individual who was more than likely Sgt. Martin.<sup>19</sup> **Martin**<sup>19</sup> described the person as a female "commander" who she said sat behind the desk.<sup>20</sup> Based on this description, this individual was likely a desk sergeant and not the commander of the 14<sup>th</sup> district. **Sector** said that this individual told her that Americans had privileges because they were born here.<sup>21</sup>

In her statement, **Sector 14** a female migrant who was staying at the 14<sup>th</sup> district, described an individual who was more than likely Martin.<sup>22</sup> **Mathematical States** that a male officer translated for an individual who was more than likely Martin.<sup>23</sup> **Mathematical States** and that this male officer translated Martin as saying that the Americans had more privileges than the migrants.<sup>24</sup>

In her statement, Sgt. Martin denied saying that the migrants should have entered the U.S. in a legal way.<sup>25</sup> Martin also denied saying that the migrants bring in disease and/or illness.<sup>26</sup> Martin denied that she said U.S. citizens have privileges over migrants.<sup>27</sup>

In Sgt. Michael Edens' statement, he said that the district council meetings are done approximately every month.<sup>28</sup> He said that he did not remember whether one of these meetings took place on May 24, 2023, but that Martin has been brought up during several of these meetings.<sup>29</sup> Additionally, Edens stated that he recalled the meeting where the issue of a COPA complaint in connection with Martin was raised by Vargas to him and Collazo.<sup>30</sup> Vargas told them Martin was hostile towards the migrants at the station.<sup>31</sup> And that Vargas asked Collazo and Edens to file a COPA complaint in connection with Martin's dog and a migrant; however, he said that Vargas said that she had already filed a COPA complaint in connection with the dog.<sup>32</sup>

Edens said that he did not recall whether Vargas requested that they file a complaint in connection with Martin other than in connection with the dog issue.<sup>33</sup> Edens stated that they would not file a complaint in connection with the dog because Vargas had already done so.<sup>34</sup>

In her statement, Commander Collazo said that she had meetings with district council members every month.<sup>35</sup> Collazo said that in these meetings they would discuss community-related matters.<sup>36</sup> She stated that she did not recall receiving a complaint about Martin from Vargas or any other individual.<sup>37</sup> She said that a sworn member would have taken minutes during their district council meetings.<sup>38</sup> COPA attempted to obtain those notes but ultimately could not find them.<sup>39</sup>

## III. ALLEGATIONS

#### Sgt. Mary Martin:

- 1. Using language intended to taunt or denigrate individuals.
  - Sustained, Violations of Rules 2, 3, 6, 8, and 9.

### Sgt. Michael Edens:

- 1. Failing to submit a complaint to the Civilian Office of Police Accountability.
  - Not Sustained

### Commander Elizabeth Collazo:

- 1. Failing to submit a complaint to the Civilian Office of Police Accountability.
  - Not Sustained

# IV. CREDIBILITY ASSESSMENT

The credibility of an individual relies primarily on two factors: 1) the individual's truthfulness; and 2) the reliability of the individual's account. The first factor addresses the honesty of the individual making the statement, while the second factor speaks to the individual's ability to accurately perceive the event at the time of the incident and then accurately recall the event from memory.

COPA believes all involved parties provided accounts of the taunting and denigrating incident that were true and accurate to the best of their knowledge. However, since the statements of the two migrants appear to support the idea that Martin had biases against migrants, COPA finds it likely that Vargas' allegation against Martin is an accurate recollection of the conversation that took place between Vargas and Martin.

Regarding the statements in connection with the allegations of not submitting a complaint to COPA, COPA believes all involved parties provided accounts of the incident that were true and accurate to the best of their knowledge. Given the extended time between the date of the meeting (May 2023) and the interviews with Edens (November 2023) and Collazo (March 2024), it is understandable that their accounts of what was discussed are different from the statements of Vargas (June 2023) and Orlikoff (June 2023).

Since COPA was unable to obtain any third-party evidence of what was discussed in this meeting, COPA cannot determine whose accounts were more accurate.

# V. ANALYSIS<sup>40</sup>

#### a. Using Language Intended to Taunt or Denigrate Individuals

COPA finds the allegation that Sgt. Martin used language intended to taunt or denigrate individuals is **Sustained**. According to General Order G02-04 Prohibitions Regarding Racial Profiling and Other Bias-Based Policing, Department members will not use language or take action intended to taunt or denigrate an individual, including racist or derogatory language.<sup>41</sup> In her statement, Vargas said that Martin indicated that the migrants should have "done this the legal way."<sup>42</sup> Vargas also said that Martin would not let them sleep in the lobby because she said that they have diseases and illnesses.<sup>43</sup> Martin denied Vargas' claims.<sup>44</sup> COPA found no evidence or received other statements supporting Vargas' claims.

However, two migrants in their statements to COPA claimed that Martin said (or was translated as saying) that Americans had privileges over migrants.<sup>45</sup> While those two migrants did not report hearing the specific words in this case, they did hear Martin make anti-migrant comments. Indeed, both migrants independently reported hearing Martin say words to the effect of Americans have more privileges over migrants. Therefore, COPA finds by a preponderance of the evidence that Martin is capable of and likely made the anti-migrant comments Vargas alleged in this case. Because Martin's language violated G02-04, COPA finds this allegation is **Sustained**.

#### b. Failing to Submit a Complaint to the Civilian Office of Police Accountability

COPA finds the allegation that Sgt. Edens and Cmdr. Collazo failed to submit a complaint to the Civilian Office of Police Accountability is **Not Sustained**. According to General Order G08-01-02, Department members will submit complaints to the Civilian Office of Police Accountability (COPA) within 24 hours of receiving a complaint.<sup>46</sup> A search of COPA's complaints database show no records of a complaint filed by CPD members on behalf of Vargas and her complaint against Martin.<sup>47</sup>

Vargas said during a May 24, 2023, meeting she asked whether Collazo would make a COPA complaint and that Collazo said that she would not.<sup>48</sup> Orlikoff said during that meeting Collazo told Ashley that Collazo did not want to file a COPA complaint and suggested that Vargas file the complaint herself.<sup>49</sup> Edens told COPA they did not submit the complaint because they were told that Vargas had already submitted a COPA complaint regarding Martin's dog. Edens could

not recall whether Vargas requested that they file a complaint in connection with Martin's handling of migrants. However, Vargas did not become aware of the alleged dog incident until June 6, 2023, which was approximately two weeks after the May 24, 2023, meeting.<sup>50</sup> Therefore, it appears that Edens was likely recalling the meeting that took place in June 2023, or later. Given that there was approximately a half year between this meeting and Edens' statement, it is within reason that his memory would be imperfect. Moreover, in Collazo's statement, she did not recall receiving a complaint about Martin from Vargas or any other individual.<sup>51</sup>

In sum, Vargas and Orlikoff stated that Edens and Collazo failed to file a COPA complaint in connection with Martin while Edens and Collazo have different recollections likely impacted by the time between events and repetitive nature of monthly meetings that can impact memory.<sup>52</sup> As there is no third-party evidence, and neither party presented credibility concerns, it is not possible for COPA to say by a preponderance of the evidence that Vargas and Orlikoff's recollections are more accurate than Edens' and Collazo's recollections. Therefore, COPA finds the allegation that Sgt. Edens and Commander Collazo failed to file a COPA complaint is **Not Sustained.** 

## VI. DISCIPLINARY RECOMMENDATION

### a. Sgt. Mary Martin<sup>53</sup>

### i. Complimentary and Disciplinary History<sup>54</sup>

Sgt. Mary Martin has received 81 complimentary awards, including 56 honorable mentions, seven Department commendations, and six complimentary letters. Sgt. Martin has not been disciplined.

### ii. Recommended Discipline

Sgt. Martin retired during this investigation, effective December 31, 2023. While COPA finds the allegation against Sgt. Martin is Sustained, COPA withholds rendering a disciplinary recommendation. However, if Sgt. Martin were to return to the Department, COPA will issue a disciplinary recommendation. This log will be placed in a Close Hold.

#### Appendix **B**

#### Definition of COPA's Findings and Standards of Proof

For each Allegation, COPA must make one of the following findings:

- 1. <u>Sustained</u> where it is determined the allegation is supported by a preponderance of the evidence;
- 2. <u>Not Sustained</u> where it is determined there is insufficient evidence to prove the allegations by a preponderance of the evidence;
- 3. <u>Unfounded</u> where it is determined by clear and convincing evidence that an allegation is false or not factual; or
- 4. <u>Exonerated</u> where it is determined by clear and convincing evidence that the conduct described in the allegation occurred, but it is lawful and proper.

A **preponderance of evidence** can be described as evidence indicating that it is **more likely than not** that a proposition is proved.<sup>55</sup> For example, if the evidence gathered in an investigation establishes that it is more likely that the conduct complied with CPD policy than that it did not, even if by a narrow margin, then the preponderance of the evidence standard is met.

**Clear and convincing evidence** is a higher standard than a preponderance of the evidence but lower than the "beyond-a-reasonable doubt" standard required to convict a person of a criminal offense. Clear and convincing can be defined as a "degree of proof, which, considering all the evidence in the case, produces the firm and abiding belief that it is highly probable that the proposition . . . is true."<sup>56</sup>
