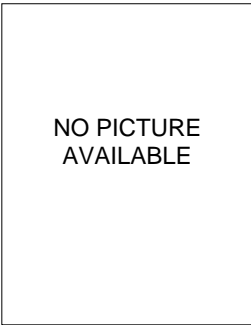

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)
 E#10482. BWC event. In summary ro/s in full uniform and marked squad car#7924 responded to a call of a person with a gun, domestic related at [REDACTED] En route to the address of the call, ro/s were waived down by the victim, [REDACTED] who related to ro/s non-verbatim "i just got hit in the head with the gun, he went that way, he's wearing white shirt and black jogging pants." Ro/s began heading west where the victim related the offender was running towards the west alley of hermitage, at which point ro/s observed a male/1 wearing a white shirt black jogging pants running northbound in the west alley of hermitage towards 81st street. Ro/s still inside marked squad car with windows rolled down initiated emergency equipment and began relocating towards the male giving verbal commands to stop. Ro/s while inside the vehicle observed the male who kept running disregarding verbal commands, clutching around the waistband multiple times and with his right hand reach towards his waistband and throw a black handgun up in the air towards the roof of garages while still running north. P.O Murphy#17179, who was the passenger of the squad car, exited squad car and initiated foot pursuit while P.O Nunez#8377 kept driving squad car . P.O Murphy then conducted a foot pursuit on the offender. P.O Murphy was approaching the offender on foot, when the offender abruptly began to stop in front of P.O Murphy, causing P.O Murphy and the offender to collide due to P.O Murphy not being able to stop on time. As P.O Murphy collided with the offender, the offender fell to the ground and struck his head on the ground concrete. Ao/s then placed the male/1 now known as Curry, David in custody. The Arrestee was transported to Christ hospital by CFD in fair condition. P.O Nunez recovered and made safe a black steel Glock 19 loaded with one in the chamber, silver "switch", laser attachment and an extended magazine with an unknown number of rounds at 8132 S Hermitage ave. Leads inquiry revealed arrestee to not have a valid foid/ccl. Name check revealed arrestee to have a previous AGG UUV case. Gun clear through hot desk. TRR#2024-03168/Foot pursuit #2417510870 completed. Pending ASA felony review.
