EVENT# 02888 IN SUMMARY R/O (THOMPSON # 18889) HEARD AUDIBLE SOUNDS OF LOUD REPORTS FROM THE LOCATION OF 8422 SOUTH ELIZABETH. R/O RELATED TO 602S THAT THERE WERE LOUD REPORTS IN THE AREA, WHICH LATER CAME OUT AS SHOTSPOTTER # 307-554341(1) ROUND; 307-554340(2) ROUNDS;397554339L (1) ROUND 307-554339.BT#611(ALLEN#13510) SIMULTANEOUSLY BEGAN ASKING FOR ASSISTANCE AT 8435 S. RACINE AVENUE. UPON ARRIVAL, R/O SPOKE TO [REDACTED] (86), WHO RELATED THAT HE WAS DRIVING HIS AND NOTICED TWO DOGS MAULING AND BITING A FEMALE [REDACTED] (38) IN THE GRASS IN FRONT OF 8435 S. RACINE. MR. [REDACTED] WHO IS A CONCEALED CARRY HOLDER AND MILITARY VETERAN RELATED THAT AFTER SEEING THE WOMEN GETTING MAULED BY THE DOGS, HE STOPPED HIS VEHICLE AND PULLED OUT HIS GLOCK 43 SERIAL # [REDACTED] AND DISCHARGED 2 ROUNDS IN GREY PIT-BULL. AND THEN 1 SHOT TO THE BROWN PIT-BULL. THE GREY PIT-BULL WAS STILL MAULING MS. [REDACTED] AND AT WHICH TIME OFFICER ALLEN DISCHARGED HER FIREARM STRIKING THE GREY PIT-BULL. P.O ALLEN REQUESTED MEDICAL ATTENTION FOR MS. [REDACTED] UPON ARRIVAL ON SCENE CFD AMB#30 TRANSPORTED MS. [REDACTED] TO CHRIST HOSPITAL WITH NUMEROUS BITE WOUNDS. AFTER ASSISTING UNITS CAME ON SCENE, OFFICERS WERE ABLE TO LOCATE THE BROWN DOG IN THE UPSTAIRS BEDROOM DECEASED. MS. [REDACTED] WAS SEEN AT THE HOSPITAL BY DR. [REDACTED] R/OS NOTIFIED ANIMAL CONTROL, WHERE OFFICER LOZO#344, AND ANDERSON#338 ARRIVED ON SCENE AND TRANSPORTED DOGS TO THEIR FACILITY ON WESTERN. WHILE ON SCENE THE HOMEOWNER [REDACTED] CAME ON THE SCENE AND LEARNED WHAT HAD HAPPENED. THE DETECTIVE DIVISION WAS NOTIFIED, WHO RELATED THAT THEY WOULD NOT BE COMING OUT. THE CRIME LAB WAS ALSO NOTIFIED AND ALSO RELATED THEY WOULD NOT BE COMING OUT. BT#621 PICKED UP THE CASING ON BWC AND COMPLETED THE INVENTORY OF INVENTORY THREE SHELL CASINGS (INV#15591792). VICTIMS GIVEN VIN AND ANIMAL BITE CARD GIVEN TO OWNER OF DOGS.
